# **Brainstorming:**

**Case #1--**Kami Arnell, Specialty Hospital of Utah—Patient's family moving to Fresno, patient has a trach and G-tube, needs MediCal 2017 to be already in place, and needs a commitment from a physician.

Family Support Organizations (9)

**Case #2**--Marilyn Howe, Integrated Services—a need for affordable caregiver and/or respite for family with autistic child.

Per Gina: Medicaid does not pay unless you're on a Medicaid waiver. DWS income level has been raised for respite stipend to offset costs for caregivers. Also, some families have created their own respite coops with other families because of the severe lack of these kinds of resources.

<u>Utah Developmental Assessment Clinics (UDAC)</u> are moving to Primary Children's Outpatient Services. To minimize wait time, ask for an **intake visit**, which can be done via telehealth. ## Presenter: Jaron Poulson, CFP – Special Needs Planning

Mr. Poulson presented an overview of the ways a (specialized) financial planner can help with special needs planning; see attached "Life Care Plan" document. A Special Needs Trust can cost between \$2000 to \$10,000 to set up. Subsequent changes may be small or could run as much as \$500. These costs can be a barrier to families who are just getting by.
